



Referral into an IDVA Service

The Independent Domestic Violence Advisor (IDVA)

The role of the IDVA is to coordinate a multi-agency response to a victim of domestic abuse assessed to be at high risk of serious harm or homicide. The IDVA will provide independent representation and advocacy for the victim through the MARAC process. They will be the voice of the victim of abuse at the Marac meeting.

About this form

This form, when completed will contain personal information (data) including special category (sensitive) data. You are required to comply with General Data Protection Regulations in the processing (including storage & retention) of this data. Please refer to your internal Data Protection Policy; local Marac Operating & Information Sharing Protocols; the GDPR and the Data Protection Act 2018.

Article 5 of the GDPR sets out seven key principles which lie at the heart of the general data protection regime. These principles should lie at the heart of your approach to processing personal data.

Compliance

It is the responsibility of the referring agency to comply with GDPR and the seven key principles. Compliance within the spirit of these key principles is a fundamental building block for good data protection practice. It is also key to your compliance with the detailed provisions of the GPDR. Failure to comply with the principles may leave you open to substantial fines.

Purpose

The purpose of a referral to IDVA is to provide only the relevant information required to enable the IDVA team to process the personal data and have adequate information necessary to enable safe contact with the victim of domestic abuse. The form also serves to share information that is relevant and proportionate to the risk and may include details of incidences of abuse & sensitive information that informs the risk assessment. Thus, removing the necessity for the victim of domestic abuse to repeat their story where possible.
